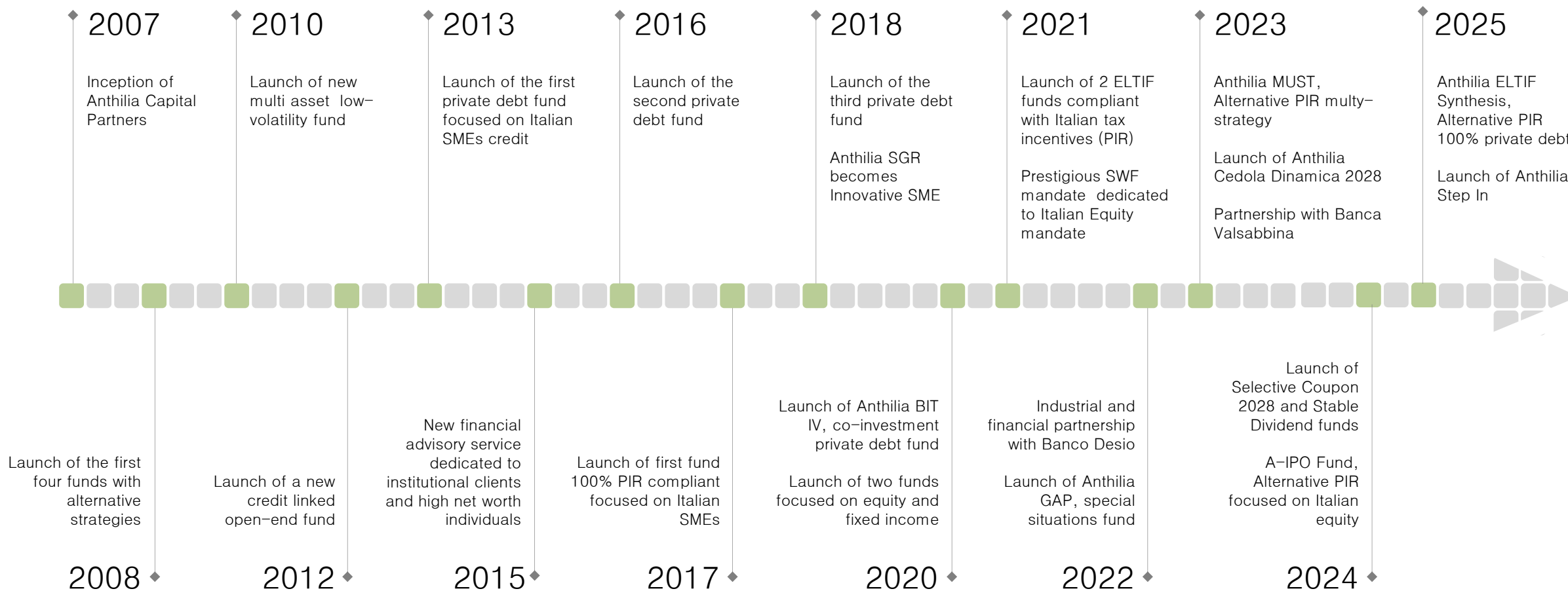

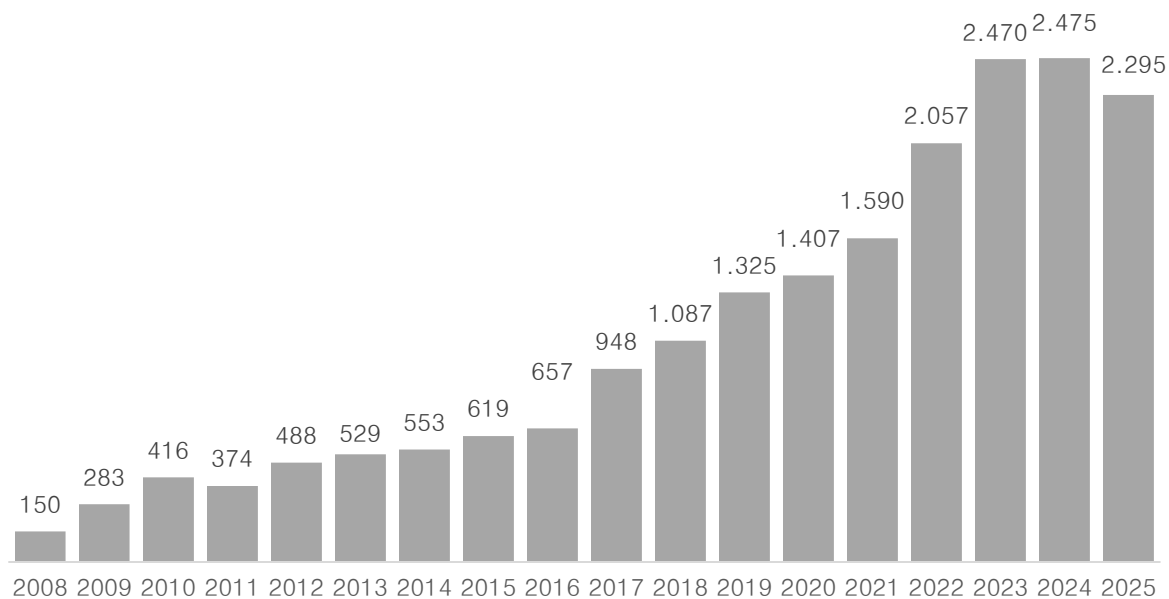

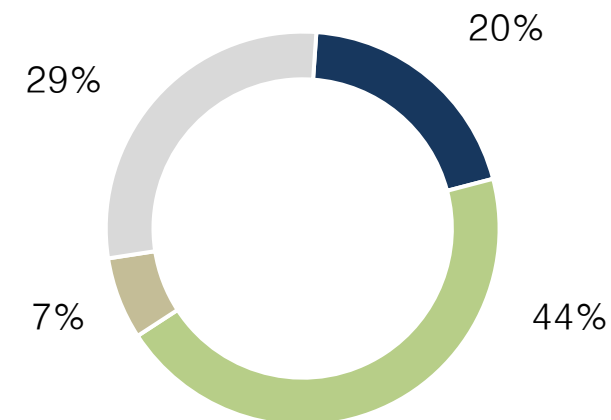
Asset base evolution and breakdown

(new high watermark marked every year)

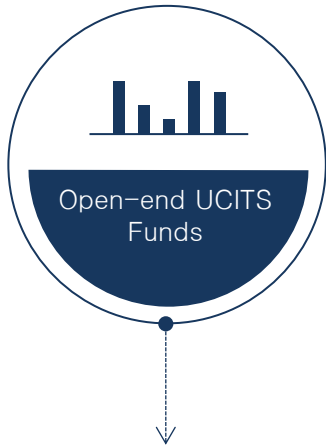
